Terms of Service for Bitcoin Daily LLC

1. Acceptance of Terms

2. Description of Service

Bitcoin Daily Trading Group offers various trading-related services through our VIP membership packages, each designed to cater to different aspects of trading. Our services include:

1. **Leveraged Signals Membership:**
 - Provides members with Leverage Trade signals with expert trade plans, including risk management and target strategies.
 - Offers weekly market analysis and altcoin analysis to inform trading decisions.
2. **Algo Signals Membership:**
 - Delivers algorithm-based trade signals for enhanced trading precision.
 - Provides access to detailed market and altcoin reports.
3. **Option Signals:**
 - Specializes in crypto option signals, focusing on selling Calls/Puts for income generation.
 - Members receive regular market and altcoin analysis reports.
4. **Algo Alerts**
 - Includes scalp alert services that notify members of key market movements and opportunities.
5. **Indicators Membership:**
 - Offers access to unique trading indicators designed for crypto market analysis.
 - Includes standard market and altcoin analysis reports.

All services are provided exclusively through our Discord group and are subject to the terms and conditions outlined in this agreement. Our services are intended to offer informational insights and should not be construed as financial advice.

3. Membership

Membership to **Bitcoin Daily Trading Group** grants access to our exclusive trading signals and analysis services. We offer various membership tiers, each tailored to different trading needs and preferences.

3.1 Subscription Fees

- **Leveraged Signals Membership:** Priced at \$49.99 per month, this membership offers expert trade plans, weekly market analysis, and altcoin analysis.
- **Algo Signals Membership:** The subscription fee for this membership, which includes algorithm-based trade signals, and market reports, is priced at \$79.00 per month
- **Options Membership:** The fee for this membership, offering crypto option signals and regular market reports, is priced at \$99 per month
- **Indicators Membership:** The fee for access to unique trading indicators and standard market reports is priced at \$49 per month
- **Algo Alerts Membership:** Includes scalp alert services that notify members of key market movements and opportunities, priced at \$29 per month

Payment Methods and Billing Cycles:

- **Accepted Payment Methods:** We accept payments via Credit Card, Apple Pay, Google Pay, Crypto
- **Billing Cycle:** Subscription fees are billed either monthly, every 3 months, every 6 months or on a yearly basis, depending on which Subscription the user signs up for, starting from the date of subscription initiation. Members will be automatically charged the subscription fee billing cycle, unless the membership is cancelled.
- **Renewal:** Subscriptions are automatically renewed at the end of each billing cycle.

Members are responsible for ensuring their payment information is up to date. Failure to process payment due to outdated or incorrect payment information may result in suspension or termination of the membership.

Changes in subscription fees, payment methods, or billing cycles will be communicated to existing members at least 30 days in advance.
