#### PRIVACY POLICY STATEMENT

Information We Collect:

#### a. Email Newsletter:

When you subscribe to our free email newsletter, we collect your email address. Optionally, you may provide us with your name and other contact information.

### b. Discord Community:

When you join our paid online community hosted on Discord, we collect your email address. Optionally, you may provide us with your name, Discord username and other contact information.

Use of Personal Information:

### a. Email Newsletter:

We use the personal information collected through our free email newsletter to send you regular updates, news, promotions, and other relevant content related to our company and services. We may also use this information to personalize the content and improve our communication with you.

# b. Discord Community:

The personal information collected for our paid online community is used for the following purposes:

- Providing access to the online community and its associated features.
- Verifying your eligibility for membership and managing your account.
- Communicating with you regarding community-related matters, updates, and support.
- Enforcing our community guidelines and terms of service.
- Analyzing and improving our community and related services.

Data Sharing and Disclosure:

#### a. Service Providers:

We may share your personal information with trusted third-party service providers who assist us in operating our website, delivering emails, managing our community, and providing other related services. These service providers are bound by confidentiality agreements and are prohibited from using your personal information for any other purpose.

# b. Legal Compliance:
