

Suits Commerce Terms of Service

Introduction

Welcome to Suits Commerce, an online community and educational platform dedicated to teaching the business model of dropshipping. By purchasing access to Suits Commerce via the Whop platform, you agree to the following terms of service. These terms outline the rules and guidelines for using our Discord community and accessing our video course.

Lifetime Access

- Discord Community: Upon purchasing Suits Commerce, you are granted lifetime access to our Discord community, meaning access for as long as the community remains open.
- Video Course: You are also granted lifetime access to our video course, which includes over 10 hours of video tutorials, as long as the course remains available.

Content and Updates

- The video course provided is complete, and while "The Suits" may add new content at their discretion, they are under no obligation to do so.
- Participation from "The Suits" in the Discord community, including responding to messages, is also at their discretion. There is no obligation for them to reply to any specific inquiries.

Membership Revocation

Membership access to both the course and the Discord community can be revoked at any time, without prior warning or refund, for violating any of the community rules outlined below:

Community Rules

1. Chat Use:

- Keeg Chat: General conversation.
- Ecom Chat: E-commerce related discussions.
- Heavy Hitters Chat: For members who have achieved \$1M+ in total revenue. Proof of revenue is required for access.
- Kings Chat: For members who have achieved \$10M+ in total revenue. Proof of revenue is required for access.

2. Content Sharing:

- No sharing or distributing any content or videos from the Discord or course. Unauthorized distribution will result in immediate membership revocation without a refund.

3. Account Sharing:

- No sharing of Discord or video platform accounts. Violation will lead to a ban without a refund.

4. Promotion Restrictions:

- No promoting other Discords or services without permission. Unauthorized promotions will result in a ban without a refund.

5. Direct Messaging:

- Do not DM "The Suits" unless instructed. Questions should be posted in the appropriate

channels to benefit all members. For specific inquiries, book a consulting call.

6. Question Repetition:

- Avoid asking questions that have already been answered in the videos or channels. Members should watch all content and stay updated with the latest information to prevent redundancy.

7. Spam:

- Excessive spamming is prohibited. Personal topics should be confined to the "Keeg Chat". Repeated spamming will result in warnings or bans.

8. Conduct:

- While free speech is encouraged, extreme racism or bullying will not be tolerated. Warnings will be issued, and repeated offenses will lead to bans.

9. Product and Store Posting:

- Do not post your products or stores in the Discord. Sharing such information may lead to it being copied by others, and we cannot police or be responsible for this.

10. Content Leaks:

- Any member caught leaking information, videos, or chats to non-paying individuals will have their access revoked immediately without a refund. Threats of leaking information are also grounds for revocation.
