

## **Bravo Six Picks Privacy Policy**

Bravo Six Picks ("we," "us," "our") respects your privacy and is committed to protecting the personal information you share with us. This Privacy Policy explains how we collect, use, disclose, and safeguard your personal information when you visit or use our services through Whop.com or any related platforms ("Services"). ### **1. Information We Collect**
