

Terms of Service

Welcome to **SOLMAFIA** (the "Service"), a crypto memecoin trading community accessed via our private Discord server. By purchasing a membership and accessing our Service, you ("Member," "User," or "You") acknowledge that you have read, understood, and agree to be bound by these Terms of Service ("Agreement," "Terms"). If you do not agree to these Terms, you may not access or use the Service.

1. Membership & Payment

1.1 Membership Fee

The monthly membership fee for SOLMAFIA is \$100 (the "Fee"). By subscribing to the Service, you agree to pay the Fee, which grants you access to our private Discord community for one month.

1.2 Recurring Billing

Unless otherwise specified or agreed, your payment method will be charged automatically on a recurring monthly basis. You are responsible for ensuring that the payment method you provide is valid and up to date.

1.3 Refund Policy

We offer a 48-hour refund policy from the time of initial purchase ("Refund Period"). To request a refund, you must contact us in writing (e.g., via email or support ticket) within 48 hours of your initial purchase.

After the Refund Period has elapsed, no refunds will be issued for the current billing cycle.

1.4 Termination of Membership

You may cancel your membership at any time. However, there are no prorated refunds for partial months. If you cancel after the Refund Period has passed, you will retain access to the Service until the end of your current billing cycle.
