

# PRIVACY POLICY

This Privacy Policy (“Policy”) describes how **Bandar, LLC** (d/b/a “Bandar’s Bounties”) (hereinafter “Company,” “we,” “us,” or “our”) collects, uses, discloses, and safeguards your information when you visit our Website <https://www.bandarsbounties.com> or engage with our subscription services, including associated eCommerce platforms, social media channels, or any other sites or platforms operated by us (collectively, the “Site” or “Services”). By accessing or using our Site, you consent to the practices described in this Policy.

If you do not agree with the terms of this Privacy Policy, **please do not access the Site or use our Services.**

## 1. SCOPE AND APPLICATION

This Policy applies to all information collected through your use of our Site and Services, including but not limited to subscription registrations, online purchases, and email communications. It also applies to information we may collect offline, such as through customer support or event registrations, to the extent such information is combined with data collected online.

## 2. INFORMATION WE COLLECT

We collect both “**Personal Information**” (information that identifies you or can be reasonably linked to your identity) and “**Non-Personal Information**” (information that does not identify you personally).

### 2.1 Personal Information

We may collect the following types of Personal Information when you voluntarily provide it to us or when you use certain features of our Site or Services:

- **Name** (First and Last)
- **Email Address**

- **Payment Information** (e.g., credit card number, billing address) when you purchase products or services
- **Account Credentials** (username, email, or similar identifiers if you register an account)
- **Any Additional Information** you voluntarily provide (e.g., contest entries, survey responses)

We do not collect additional categories of Personal Information unless you choose to share them. However, you may be required to provide Personal Information to access certain services or functionalities, such as:

- Creating an account
- Entering sweepstakes or contests
- Signing up for special offers
- Submitting inquiries to customer support
- Completing a purchase (recurring subscriptions or otherwise)

## 2.2 Non-Personal Information

When you visit the Site, our servers or authorized third-party service providers may collect certain **Non-Personal Information** automatically, including:

- **IP Address**
- **Browser Type & Version**
- **Device Information** (e.g., operating system, hardware model)
- **Domain Names**
- **Access Times & Referring Website Addresses**
- **General Geolocation** (approximate region, not exact GPS data)

This data helps us maintain the quality and functionality of our Services, troubleshoot technical issues, analyze usage trends, and enhance the user experience.

### 3. HOW WE USE YOUR INFORMATION

We use the information we collect for a variety of business and operational purposes, which may include:

**1. Service Delivery:**

- Processing your orders, subscriptions, or other transactions.
- Providing access to paid content, resources, and any requested digital products or recurring subscription benefits.

**2. Communication:**

- Sending administrative information, such as account or service-related notices, confirmations, or updates.
- Responding to your requests, questions, or concerns submitted via email or other communication channels.

**3. Marketing & Promotions:**

- Informing you of new products, services, discounts, or special offers that may be of interest to you.
- Conducting surveys, contests, or sweepstakes and communicating results as necessary.

**4. Analytics & Improvements:**

- Monitoring usage trends, measuring campaign effectiveness, and analyzing how users engage with our Site.
- Developing new features, products, or services and improving existing ones.
- Enhancing security measures, diagnosing server/technical issues, and preventing fraudulent activities.

**5. Legal & Compliance:**

- Complying with applicable laws, regulations, or legal processes.

- Protecting our rights or property, enforcing the terms of our agreements, detecting or preventing fraud, and addressing security or technical concerns.

## 4. HOW WE SHARE YOUR INFORMATION

**We do not sell, rent, or lease** your personal information to third parties. We only share your data in the following limited circumstances:

1. **Service Providers / Trusted Partners:**

We may share data with trusted third-party companies that assist us in operating our business, such as payment processors, website hosting providers, analytics services, email service providers, or marketing platforms. These third parties are required to handle your information only for our authorized purposes and keep it confidential.

2. **Business Transactions:**

In the event of a merger, acquisition, financing, or sale of all or a portion of our assets, we may transfer user information (including Personal Information) to the acquiring entity as part of the transaction, subject to the acquirer's commitment to honor this Policy.

3. **Legal Obligations & Protection:**

We may disclose your information if required to do so by law (e.g., in response to a valid subpoena or court order) or if we believe such action is necessary to:

- Conform to legal requirements or defend our legal rights.
- Protect the safety and security of our users or the general public.
- Enforce our agreements, terms, or policies.

4. **Consent:**

We may share or disclose your information in any other situation where you have given **express consent** to the disclosure.

---

## 5. COOKIES & TRACKING TECHNOLOGIES

We use **cookies**, **web beacons**, and similar tracking technologies to automatically collect information about your browsing activities on our Site. These technologies help us:

- Remember your preferences and settings.
- Understand and analyze site traffic and usage patterns.
- Deliver relevant advertisements or personalized content (where applicable).

You can usually modify your browser settings to block or disable cookies if desired; however, doing so may limit certain features or functionality on our Site.

## 6. DATA SECURITY

We implement a variety of **security measures** to protect your information from unauthorized access, use, or disclosure. These may include:

- **Encryption via SSL/TLS** protocols during data transmission (e.g., credit card information).
- **Restricted Access** controls so that only authorized personnel or service providers can access your Personal Information.
- **Monitoring & Logging** tools to detect and prevent suspicious activity.

Despite our best efforts, **no method of electronic transmission or storage is 100% secure**. By using the Site, you acknowledge that we cannot guarantee absolute security of your data, and you agree to assume the associated risks.

---

## 7. RETENTION OF PERSONAL INFORMATION

We retain your Personal Information **only for as long as** it is necessary to fulfill the purposes outlined in this Policy or comply with legal obligations, resolve disputes, and enforce our agreements. The exact retention period depends on factors such as the nature of the data, why it was collected, and applicable regulatory requirements.

## 8. RIGHT TO DELETION (CALIFORNIA & OTHER APPLICABLE LAWS)

If you reside in a jurisdiction that grants you the **right to request deletion** of your Personal Information:

- **Deletion Request:** You may request that we delete any Personal Information we hold about you.
- **Service Providers:** We will also instruct our service providers to delete your information from their records, subject to the limitations below.

**Exceptions:** We may not be able to delete your information if it is necessary to:

1. Complete the transaction for which it was collected, provide a product or service requested by you, or otherwise perform a contract between you and us.
2. Detect, prevent, or prosecute malicious, deceptive, fraudulent, or illegal activity.
3. Debug and repair errors that impair existing intended functionality.
4. Exercise free speech or enable another consumer's right to free speech.
5. Comply with the California Electronic Communications Privacy Act or any other legal obligations.
6. Engage in legitimate public interest research that adheres to relevant ethics and privacy laws and would be severely impaired by deletion.
7. Make only internal uses aligned with your relationship with us or otherwise use your information lawfully in a manner compatible with the context in which it was provided.

## 9. CHILDREN'S PRIVACY

We do not knowingly collect Personal Information from children under 13 without parental consent.

Your continued use of the Site or Services after any modifications indicates your acceptance of the revised Policy.
