

# YewScripts EULA

This End-User License Agreement ("EULA") is a binding agreement between you ("you," "your," or "User") and YewScripts ("YewScripts," "we," "us," or "our") and governs your access to and use of all scripts, configurations, instructions, enhancements, and related digital products or services (collectively, the "Scripts") provided by YewScripts. This includes any updates, upgrades, patches, or modifications (collectively, the "Updates").

By downloading, installing, accessing, or using the Scripts, you agree to be bound by this EULA and our Privacy Policy, incorporated herein by reference. If you do not agree to this EULA, do not download, install, or use the Scripts.

## 1. License Grant

Subject to your compliance with this EULA, YewScripts grants you a personal, limited, non-exclusive, non-transferable, non-sublicensable, and revocable license to download, install, and use the Scripts strictly for your own personal, non-commercial use. This license does not convey any ownership or intellectual property rights. All rights not expressly granted are reserved by YewScripts.

## 2. Restrictions on Use

You agree not to, and will not permit others to:
