

# DesiTradeLLC Terms of Service for Options Insider Trading Community

**Effective Date: April 11, 2025**

Welcome to the Options Insider Trading Community (the “Community”), a Discord-based platform operated by DesiTradeLLC, a Florida-based company (“we,” “us,” or “our”). These Terms of Service (“Terms”) govern your access to and participation in the Community. By joining, accessing, or using the Community, including purchasing a subscription or engaging in discussions, you (“you” or “Member”) agree to be bound by these Terms, our [Privacy Policy]([insert link to Privacy Policy]), and our [Return Policy]([insert link to Return Policy]). If you do not agree, please do not join or participate in the Community.

## 1. Acceptance of Terms

Your purchase of a subscription, creation of a Community account, or participation in any Community activities (e.g., posting messages, joining voice channels, or sharing trading strategies) constitutes your agreement to these Terms. We may update these Terms at any time, and we will notify you of material changes via a Community announcement or email to the address associated with your account. Continued use of the Community after such updates signifies your acceptance of the revised Terms.

## 2. Eligibility and Account Responsibilities

To join the Community, you must meet the following requirements:

- **Age Requirement:** You must be at least 18 years old, as day trading involves financial risks and requires legal capacity. We do not permit users under 18, even with parental consent.
- **Discord Account:** You must have a valid Discord account, subject to Discord’s [Terms of Service](#) and [Community Guidelines](#).

- **Compliance with Laws:** You must comply with all applicable local, state, federal, and international laws, including those related to financial activities and online conduct.

You are responsible for:

- Maintaining the confidentiality of your Discord account credentials.
- Notifying us immediately at [admin@options-insider.com](mailto:admin@options-insider.com) of any unauthorized access to your account.
- Using only one account to access the Community. Sharing or distributing account credentials is prohibited.

We reserve the right to refuse or terminate membership if you fail to meet these requirements or for any other lawful reason.

### 3. Community Conduct

The Community is designed to foster respectful, productive discussions about day trading and financial markets. To maintain a positive environment, you agree to follow these rules:

- **Respect Others:** Treat all members with courtesy. Harassment, hate speech, discrimination, or bullying based on race, gender, religion, or any other characteristic is strictly prohibited.
- **No Spam or Promotions:** Do not post repetitive messages, irrelevant content, or unsolicited advertisements, including promotions of other trading services or products.
- **No Illegal Content:** Do not share content that is illegal, fraudulent, or infringes on third-party rights (e.g., copyrighted material, trade secrets).
- **No Disruptive Behavior:** Avoid trolling, baiting, or actions that disrupt Community discussions or harmony.
- **No Inappropriate Content:** Do not post or discuss explicit, obscene, or not-safe-for-work (NSFW) content.
- **No Unauthorized Financial Advice:** Do not provide or solicit personalized financial, investment, or trading advice, as this may violate securities laws.

Violations of these rules may result in warnings, temporary suspension, or permanent removal from the Community, at our sole discretion, with no refund except as outlined in our Return Policy.

## 4. Membership and Fees

Access to the Community requires a paid subscription, which may be a one-time payment (e.g., lifetime membership) or recurring (e.g., monthly or annual plans). Details of membership tiers and fees are provided during the registration or checkout process.

- **Billing:** For recurring subscriptions, you authorize us to charge your provided payment method at the agreed intervals. You must keep your payment information current to avoid service interruptions.
- **Return Policy:** As outlined in our Return Policy, standard subscriptions (e.g., monthly or annual) are refundable within 7 days of purchase. No refunds are available after this period. Lifetime memberships are non-refundable under all circumstances, and by purchasing a lifetime membership, you accept this condition.
- **Fee Changes:** We may adjust subscription fees with prior notice. Changes will apply to new subscriptions or renewals after the effective date of the change.
- **No Guarantee of Access:** Payment does not guarantee uninterrupted access if you violate these Terms or if the Community is discontinued (see Section 6).

- **Our Right to Terminate:** We may suspend or terminate your access to the Community at any time, with or without notice, for reasons including but not limited to:
  - Violation of these Terms or Community rules.
  - Engaging in illegal or fraudulent activities.
  - Failure to pay subscription fees.
  - Conduct that harms the Community or other members.
- **Your Right to Terminate:** You may cancel your subscription or leave the Community at any time via your account settings or by contacting us at [admin@options-insider.com](mailto:admin@options-insider.com). Cancellation does not entitle you to a refund except as provided in our Return Policy.
- **Effect of Termination:** Upon termination, you will lose access to all Community features, including exclusive content and discussions. We may retain certain data (e.g., moderation logs) as required by law or for operational purposes, as outlined in our Privacy Policy.

- **No Guarantees:** We do not guarantee any financial outcomes, profits, or performance based on your use of the Community. Past performance discussed in the Community is not indicative of future results.
- **Seek Professional Advice:** Consult a qualified financial advisor before making trading or investment decisions.

DesiTradeLLC is not liable for any losses, damages, or claims arising from your reliance on Community content or participation.

## 8. Disclaimers and Limitation of Liability

You waive any right to participate in class actions or class arbitrations.

- **Force Majeure:** We are not liable for delays or failures in providing the Community due to events beyond our control, such as natural disasters, server outages, or changes to Discord's platform.
- **No Waiver:** Our failure to enforce any part of these Terms does not constitute a waiver of our rights.
