

DesiTradeLLC Discord Community Privacy Policy

Effective Date: April 11, 2025

At DesiTradeLLC, we value your privacy and are committed to protecting the personal information you share with us in our day trading Discord community. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you participate in our Discord server (the “Community”). By joining or participating in the Community, you agree to the terms of this Privacy Policy.

1. Information We Collect

We may collect the following types of information when you interact with our Community:

- **Personal Information You Provide:** This includes information you voluntarily share, such as your Discord username, messages you post in the Community (e.g., trading ideas, questions, or feedback), and any personal details you include in your profile or communications (e.g., email address, if shared privately with moderators).
- **Automatically Collected Information:** When you use Discord, certain information is collected by Discord’s infrastructure, such as your IP address, device information, and activity logs (e.g., when you join or leave the server). DesiTradeLLC may access some of this information through Discord’s tools for moderation or analytics purposes.
- **Trading-Related Information:** If you share trading strategies, portfolio details, or financial preferences in the Community, we may store or process this information to facilitate discussions or provide Community features (e.g., organizing trading challenges or leaderboards).
- **Direct Messages with Moderators:** If you communicate with our moderators or admins via private messages, we may retain

those messages to address your inquiries, resolve disputes, or enforce Community rules.

2. How We Use Your Information

We use your information to operate, maintain, and enhance the Community experience, including:

- **Facilitating Community Interaction:** To enable discussions, share trading insights, and foster collaboration among members.
- **Moderation and Safety:** To enforce our Community rules, prevent spam, harassment, or illegal activities (e.g., sharing regulated financial advice without authorization), and ensure a positive environment.
- **Improving the Community:** To analyze engagement patterns (e.g., popular channels or topics) and tailor content or features to members' interests.
- **Responding to Inquiries:** To address your questions, feedback, or concerns shared via messages or Community channels.
- **Legal Compliance:** To comply with applicable laws, regulations, or legal requests (e.g., responding to subpoenas or reporting illegal activity).

3. How We Share Your Information

We do not sell, trade, or rent your personal information to third parties. However, we may share your information in the following cases:

- **With Discord:** Our Community operates on Discord's platform, and Discord collects and processes data according to its own [Privacy Policy](#). We encourage you to review Discord's policy to understand how they handle your data.
- **With Moderators and Admins:** Your messages, username, and other shared information may be visible to our moderators or admins for Community management purposes.
- **For Legal Reasons:** We may disclose your information if required by law, such as to comply with a court order, prevent fraud, or protect the safety of our Community or others.
- **In Aggregated Form:** We may share anonymized or aggregated data (e.g., general trading trends or Community engagement

stats) that does not identify you personally, for purposes like improving the Community or promoting DesiTradeLLC.

4. Your Choices and Rights

You have control over your information in the Community:

- **Manage Your Discord Profile:** You can update or limit the information in your Discord profile, such as your username or profile picture, directly through Discord's settings.
- **Limit Shared Information:** Be cautious about sharing sensitive personal or financial details in public channels, as other members may see this information.
- **Leave the Community:** You may leave the Community at any time through Discord's interface, though we may retain certain information (e.g., moderation logs) as needed for legal or operational purposes.
- **Data Rights:** Depending on your location, you may have rights to access, correct, delete, or restrict the use of your personal information. Florida residents may have specific rights under applicable state laws. To exercise these rights, contact us at admin@options-insider.com. Note that some information (e.g., public messages) may not be fully deletable due to the nature of Discord's platform.

5. Data Security

We take reasonable steps to protect your information, such as using secure channels for moderation and limiting access to Community data. However, no online platform is completely secure, and we cannot guarantee the absolute security of your information. You are responsible for maintaining the security of your Discord account (e.g., using strong passwords and enabling two-factor authentication).

6. Data Retention

We retain your information only as long as necessary to provide Community services, comply with legal obligations, or resolve disputes. For example:

- Public messages may remain in the Community unless deleted by you or moderators.

- Private messages with moderators may be retained for documentation purposes.
- Analytics data may be stored in anonymized form indefinitely.

If you leave the Community, we may delete or anonymize your personal information, except where required for legal or operational reasons.

7. Third-Party Links and Services

Our Community may contain links to third-party websites, tools, or services (e.g., trading platforms, market data providers, or educational resources). We are not responsible for the privacy practices of these third parties. Please review their policies before sharing your information.

8. Children's Privacy

The DesiTradeLLC Discord Community is not intended for individuals under the age of 18. Day trading involves financial risks and requires maturity and legal capacity. If we learn that a user under 18 has joined the Community, we will take steps to remove their account and associated information.

9. Jurisdiction and International Users

DesiTradeLLC is based in Florida, United States, and our Community is subject to Florida and U.S. federal laws. If you participate from outside the U.S., your information may be transferred to and processed in the U.S., where privacy protections may differ from your country. By joining the Community, you consent to this transfer.

10. Changes to This Privacy Policy

We may update this Privacy Policy from time to time to reflect changes in our practices or legal requirements. We will notify Community members of material changes via a Discord announcement or email (if we have your contact information). The updated policy will take effect upon posting unless otherwise stated.
