a. Personal Information You Provide

b. Automatically Collected Information

 - Cookies and similar tracking technologies (via Whop)

We use your information to:

- Facilitate coaching, support, and community participation (e.g., via Discord)

- Process payments and manage subscriptions
 - Send transactional emails, updates, and optional marketing messages
 - Monitor, analyze, and improve our Services
 - Ensure compliance with our Terms of Service and applicable laws

We **do not sell your personal information**. We may share your information with:

- **Service Providers:** Platforms like Whop, Discord, payment processors, and analytics tools to help us operate.
 - **Partner Brands:** If you opt into receiving ad support or brand collaboration opportunities.
 - **Legal Authorities:** When required to comply with applicable law, regulation, or legal process.
