We do not directly collect or store payment information.

- Analyze user behavior (Google Analytics, Facebook Pixel, TikTok Pixel, Snapchat Pixel)

All user data is securely stored and managed via **Whop**.

TWS does not store your information directly on its servers or share it with third parties.
