

Ivolution Systems LLC - Privacy Policy

1. Introduction

Ivolution Systems LLC ("us," "we," "our," or "Company") is committed to protecting the privacy of its users ("user," "you," or "your"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you access and use our Ivolution Pulse Indicator, Ivolution Dash MTF Indicator (collectively, the "Indicators"), our website (including any subdomains), our Discord community, and related services offered through any platform, including but not limited to Whop.com ("Whop") (collectively, the "Services").

Please read this Privacy Policy carefully. By accessing or using the Services, you agree to the collection and use of information in accordance with this policy. If you do not agree with the terms of this Privacy Policy, please do not access or use the Services.

This Privacy Policy is incorporated by reference into our Terms and Conditions.

2. Information We Collect

We may collect information about you in a variety of ways. The information we may collect via the Services depends on the content and materials you use, and the actions you take, and includes:

- **Personal Data:** Personally identifiable information, such as your name, email address, Discord username, TradingView username, and potentially other contact or identification information that you voluntarily give to us when you register for the Services, subscribe, participate in our Discord community, or otherwise interact with the Services. You are under no obligation to provide us with personal information of any kind, however your refusal to do so may prevent you from using certain features of the Services.
- **Derivative Data:** Information our servers automatically collect when you access the Services, such as your IP address, browser type, operating system, access times, and the pages you have viewed directly before and after accessing the Services. If you are using our mobile application, this information may also include your device name and type, operating system, phone number, country, likes and replies to a post, and other interactions with the application and other users via server log files, as well as any other information you choose to provide.
- **Financial Data:** Financial information, such as data related to your payment method (e.g., valid credit card number, card brand, expiration date) is primarily collected and processed by third-party payment processors (like Whop or its integrated processors, e.g., Stripe). We do not directly store or control your full payment card details. We may receive transactional information from the payment processor necessary to confirm your subscription status and manage your account. Please review the privacy policy of the respective payment processor (e.g., Whop) for how they handle your financial data.

- **Data from Social Networks:** User information from social networking sites, such as Discord, including your name, your social network username, location, gender, birth date, email address, profile picture, and public data for contacts, if you connect your account to such social networks. When interacting via Discord, we may see your username, messages, and other information you make available within our community channels.
- **Third-Party Platform Data:** Information required by third-party platforms necessary to provide the Services, such as your TradingView username to grant access to the Indicators.

3. How We Use Your Information

Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the Services to:

- Create and manage your account.
- Grant access to the Indicators on third-party platforms (e.g., TradingView).
- Process payments and subscriptions (primarily via third-party processors like Whop).
- Manage your participation in our Discord community.
- Email you regarding your account or subscription.
- Respond to your inquiries and provide customer support.
- Monitor and analyze usage and trends to improve your experience with the Services.
- Notify you of updates to the Services.
- Prevent fraudulent transactions, monitor against theft, and protect against criminal activity.
- Enforce our Terms and Conditions and other policies.
- Comply with legal and regulatory requirements.
- Perform other business activities as needed.

4. Disclosure of Your Information

We may share information we have collected about you in certain situations. Your information may be disclosed as follows:

- **By Law or to Protect Rights:** If we believe the release of information about you is necessary to respond to legal process, to investigate or remedy potential violations of our policies, or to protect the rights, property, and safety of others, we may share your information as permitted or required by any applicable law, rule, or regulation.
- **Third-Party Service Providers:** We may share your information with third parties that perform services for us or on our behalf, including payment processing (e.g., Whop, Stripe), data analysis, email delivery, hosting services, customer service, platform integration (e.g., TradingView for Indicator access), and community management (e.g.,

Discord). We require these third-party service providers to use your information only as necessary to provide the specific services we have requested.

- **Business Transfers:** We may share or transfer your information in connection with, or during negotiations of, any merger, sale of company assets, financing, or acquisition of all or a portion of our business to another company.
- **Affiliates:** We may share your information with our affiliates, in which case we will require those affiliates to honor this Privacy Policy. Affiliates include any subsidiaries, joint venture partners or other companies that we control or that are under common control with us.
- **With Your Consent:** We may disclose your personal information for any other purpose with your consent.

We do not sell your personal information to third parties.

5. Security of Your Information

We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide to us, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse. Any information disclosed online is vulnerable to interception and misuse by unauthorized parties. Therefore, we cannot guarantee complete security if you provide personal information.

6. Data Retention

We will retain your personal information only for as long as is necessary for the purposes set out in this Privacy Policy, including for the purposes of satisfying any legal, accounting, or reporting requirements. We will retain and use your information to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies. Usage data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

7. Your Data Protection Rights

Depending on your location, you may have certain rights regarding your personal information under applicable data protection laws. These may include the right to:

- Request access to your personal data.
- Request correction of the personal data that we hold about you.
- Request erasure of your personal data.
- Object to processing of your personal data.

Also, be aware that we may not be able to delete certain data if we have a legal obligation to retain it or have other legitimate grounds to keep it. You can usually choose to set your browser to remove or reject cookies, but be aware that such action could affect the availability and functionality of the Services.
