By subscribing to any plan, you authorize Trend Traders Academy to charge your chosen payment method on a recurring basis according to the plan selected. Billing will continue automatically until canceled by you.

## 2.1 AUTOMATIC RENEWAL

Each plan automatically renews at the end of its term unless canceled prior to the renewal date. By purchasing a membership, you agree to recurring charges at the applicable interval (monthly, 6-month, or yearly).

## 2.2 CANCELLATION

You may cancel your subscription at any time by contacting support before your next billing cycle. Cancellations will take effect at the end of your current billing period.

No partial refunds or prorated credits will be issued.
