Privacy Policy

This Privacy Policy governs the manner in which Tactical Traders LLC, located at 8175 E Evans Rd, Scottsdale, AZ 85260 ("we" or the "Company"), collects, uses, maintains and discloses information, including personal information. This Privacy Policy applies when you: access or use our website located at: tacticaltraders.net (the "Site"); apply for and/or use Company services including any courses or coaching services offered by the Company; or contact or otherwise interact with us in any way (collectively, the "Services"). This Privacy Policy applies to all clients, visitors, and users of the Services; however, it does not apply to any third-party content or websites that are linked to or from the Site.

Information We Collect

To provide our Services and assure the Site is functioning properly, it is necessary for us to collect certain information, including personal information. Accordingly, we collect the following categories of information:

Information You Provide Directly

We may collect information that you provide us, including when you use the Site, apply to be considered for certain Services, purchase Services, request support, or contact us in any way. For example:

Application and Enrollment. In order to be considered for approval for certain Services, you may be required to provide us with certain application information, including personal information such as your email address, first and last name, and telephone number. Upon acceptance of your application, you may be required to provide us with additional information to enroll and participate in such Services. By providing us with your information, you agree that all such information is legal, accurate, current, and complete.

Purchases. If you purchase courses, coaching services, or other Services from us, we may collect your first and last name, email address, billing address, shipping address, telephone number, and/or partial payment card information.

Other Services. In order to participate in certain activities, services, features, or resources we might make available from

time to time, you may be required to provide us with your email address, first and last name, and/or telephone number.

Newsletters. If you elect to receive our newsletter, we may collect your email address.

Inquiries. If you contact us directly, we may collect the contact information that you provide including, but not limited to, your first and last name, email address, and any additional relevant information you provide us.

Information Collected Automatically

We reserve the right to automatically collect the following information when you use the Site: IP address, device hardware and software information, browser information, usage or access time, and other analytics information, including using cookies and other similar technologies.

Cookies

"Cookies" are used to store information including user preferences. This information is used, for example, to optimize user experience by customizing website content based on users' browser type and other related information. A user may be able to disable or prevent the setting of cookies by adjusting your browser settings, however, disabling cookies may prevent you from accessing certain areas of a website. For more general information regarding cookies, please see .

How We Use Collected Information:

Services. We may use your information in connection with providing and performing our services and for other related business purposes necessary in our legitimate interests. For example, we may use the information to provide our Services, process payments, provide customer support, notify you about changes to our Services, respond to inquiries, send communications, and prevent fraud.

Site. We may use your information in connection with operating, maintaining, and improving our Site, including providing educational solutions for stock market traders.

Purchases. We may use your information in connection with sending you information and updates pertaining to your purchases.

Legal. We may use your information to protect our legal rights, including for fraud prevention, and to comply with our legal obligations.

Respond to Inquiries. We may use your information to provide and improve customer support and respond to your inquiries.

Newsletters. We may use your personal information to contact you with newsletters and other information of interest related to our Site or services. You may opt-out of receiving such communications from us by following the instructions provided in our emails.

Other. We may use your personal information for any other purposes disclosed to you at the time of collection or pursuant to your consent.

Analytics. We may use aggregated information to improve our Site and services.

Confirm Identity. We may use your information to confirm your identity.

Sharing Your Personal Information:

Personal Information

We do not sell, trade, or rent your personal information to others in exchange for monetary consideration. The personal information collected through the Services is used solely for the purposes described herein. Please see the "Your Rights" section below for more information regarding exercising certain privacy rights with respect to your personal information. We will only disclose your personal information as follows:

Service Providers. We may disclose your personal information with service providers and vendors working on our behalf to assist us in providing our services including, but not limited to, credit card processors, online appointment scheduling services, and email service providers. Such entities are contractually obligated to comply with this Privacy Policy and do not have any right to use your personal information beyond what is necessary.

Affiliated Parties. We may disclose your personal information with our affiliates or subsidiaries as needed to provide our services.

Legal. We may disclose your personal information if legally required, for example, if we believe that it is necessary to comply with a law, regulation, or valid legal procedure, such as a subpoena or a court order.

Merger. We may disclose your information if we are merged with or acquired by another entity, however, such entity would be contractually obligated to comply with this Privacy Policy.

Other. We may disclose your information to unaffiliated third parties with your consent.

Our Rights. We may disclose your information to investigate fraudulent activity or breaches of security, or to protect our (or any third party's) rights.

Non-Personal Information

We may disclose aggregated information (i.e., information that cannot identify you) for any lawful purpose.

Data Security

Consistent with industry standards, we take appropriate technical and organizational measures to secure your personal information. However, we point out that no method of data transmission or storage can be 100% secure and, as such, we are not able to guarantee its security.

Data Retention

We will maintain your personal information for no longer than is necessary for the purposes for which it was collected, as may be permitted by law.

Data Transfers

We are an Arizona-based entity whose servers are housed in the United States. All information you provide to us, and all information we collect, is transferred solely within the United States, and is processed and stored according to United States law.

Children's Privacy

The Services were not developed or intended for children under 18 years of age, and we do not knowingly collect information from children under 18 years of age. Children under 18 years of age may not use the Services. If you access the Site, use our Services, or provide information to us, you represent that you are at least 18 years of age. If you are the parent or guardian of a child under 18 years of age and learn that he/she has provided us with personal information, contact us at privacy@tacticaltraders.net, and we will delete such information.

Do Not Track

We do not currently respond to "Do Not Track" signals or other similar opt-out mechanisms, other than those specifically set forth in this Privacy Policy, including general web browser "Do Not Track" settings.

Your Rights

Depending on the requirements of applicable law in the jurisdiction where you are located, you may be able to exercise the following rights with respect to your personal information:

The right to know what personal information we have collected about you, including the categories of personal

information, the categories of sources from which the personal information was collected, the business purpose for collecting or sharing personal information, the categories of third parties to whom we disclose such personal information.

The right to know whether your personal information is sold or disclosed, and to whom.

The right to access the personal information that we have collected about you.

The right to limit the use and disclosure of your "sensitive" personal information.

The right to request that we delete all or some of the personal information that we have collected about you.

The right to request that we correct any personal information that we have collected about you that is inaccurate or incomplete.

The right to receive the personal information that we hold about you in a portable and, to the extent feasible, a readily usable format that allows you to transmit this information to another entity.

The right to say no with respect to the sale of your personal information.

The right to opt out of the sharing of your personal information.

The right to opt out of the use of your personal information for the purposes of automated decision making or profiling.

The right to revoke your consent, where we rely on such consent to process your personal information, if any.

The right not to be discriminated against based upon your exercise of your privacy rights.

The right to equal service, even if you exercise any such privacy rights.

We note that any of the foregoing rights that may be available to you will depend both on our reasons for processing your personal information and the requirements of applicable law. Specifically, your particular rights will vary depending on where you reside.

However, prior to complying with any request, we will need to verify your identity. To verify your identity, you will need to provide us with certain personal information with your request, including, your first and last name, email address, and any other identification information that may be required to verify your identity in accordance with applicable law. Please note, we may be unable to process your request if you do not provide us with all such information. You may designate an authorized agent to exercise your rights

on your behalf, provided, however, in addition to providing your information, such agent will be required to verify that he/she has the authority to submit requests on your behalf. We may do so by asking the agent to submit a valid power of attorney executed by you. Please note, we may not be able to process your request if you and your designated agent do not provide us with such information.

We will respond to most requests within 30 to 45 days of receipt, depending upon where you reside, however, some requests may take longer. Please note, although we do not typically charge a fee to process requests, we may charge a fee for any additional request within a 12-month period. We will notify you in writing if we need more time to respond. Please note, we may deny your request if certain exceptions in applicable law apply. If we deny your request, we will provide you with the reason(s) for such denial. You may have the right to appeal such a denial; you may submit an appeal to us at the contact information provided above. We will respond to most appeal requests within 45 to 60 days of receipt, depending upon where you reside, however, some requests may take longer. We will notify you in writing if we need more time to respond. In our response to your appeal, we will inform you of any actions taken, or not taken, and the reason(s) regarding why.

The Site may contain links to websites or other online resources operated by third parties. We provide such links for your convenience only; we do not control such resources and are not responsible for the privacy practices of such third parties. It is your responsibility to read and understand third-party terms and privacy policies.
