**Effective Date:** July 18, 2025

Welcome to **The Six-Figure Storefront** ("*SFS*"), a private educational community hosted on the Whop platform ("*Platform*"). By joining, accessing, or using SFS you agree to be bound by these Terms of Service ("*Terms*"). If you do not accept these Terms, please do not use the community.

## 1. Acceptance & Updates

1.1 We may modify these Terms at any time. Material changes will be announced in the community or by email. Continued use after an update constitutes acceptance.

1.2 If you breach any provision, we may suspend or terminate your access without notice or refund.

## 2. Membership Types & Fees

2.1 **"Lifetime" Membership.** A one-time fee grants you access to all current SFS content and future releases **without recurring charges**.

- We guarantee to host and maintain community access for **at least four (4) months** from the date of your purchase

*("Minimum Hosting Period")*).

- After the Minimum Hosting Period, we may, at our sole discretion, continue to operate, modify, migrate, or discontinue SFS with or without notice.

2.2 All fees are stated in U.S. dollars and are non-refundable unless required by law.

2.3 You are responsible for any taxes, bank fees, or currency conversion charges.

### **3. Eligibility & Account Security**

3.1 You must be at least 18 years old and able to form a binding contract.

3.2 Keep your Whop credentials confidential. You are responsible for all activity under your account.

### **4. Community Conduct**

4.1 Treat others with respect. Harassment, hate speech, spam, or illegal activity will result in immediate removal.

4.2 Do not share, resell, or publicly distribute SFS content without written permission.

4.3 We reserve the right to moderate discussions, remove content, and enforce rules in our sole discretion.

### **5. Intellectual Property**

5.1 All videos, documents, templates, and other materials ("*Content*") are the property of SFS or its licensors and are protected by copyright and other laws.

5.2 During your valid membership, we grant you a limited, non-exclusive, non-transferable license to access and use the Content for your own business or personal education.

You may cancel your membership at any time through Whop settings (no refund). We may terminate or suspend your access for a breach of these Terms or legal requirements.

## 12. Governing Law & Dispute Resolution

These Terms are governed by the laws of the **State of**

**Colorado, USA**, without regard to conflict-of-law principles. Any dispute shall be resolved in the state or federal courts located in Denver County, Colorado, and you consent to personal jurisdiction there.

### **13. Severability**

If any provision is found unenforceable, the remaining provisions will remain in full force.

### **14. Entire Agreement**

These Terms constitute the entire agreement between you and SFS regarding community access and supersede all prior understandings.
