## 50x Club Terms of Use and Community Guidelines

- 1.1. 50x Club IFZA ("50x Club," "we," "us," or "our") is a UAE-based organization that operates a private cryptocurrency community focused on education, research collaboration, and information sharing among individuals interested in the cryptocurrency market.
- 1.2. Our services include access to our private Discord community, educational resources, market research, and collaborative cryptocurrency analysis designed to help members expand their knowledge and understanding of cryptocurrency opportunities.
- 1.3. All information, research, and content shared by 50x Club and its community members are strictly for educational and informational purposes. Nothing provided should be interpreted as financial advice, investment recommendations, or endorsements of specific investment decisions.
- 1.4. By accessing our website at 50xclub.com, joining our Discord community, or using any of our services (collectively, "the Services"), you agree to be bound by these Terms of Use.
