

50x Club Privacy Policy

Introduction

50x Club - IFZA ("Company," "we," "us," or "50x Club") values the privacy of our community members and visitors. This Privacy Policy outlines how we collect, use, and protect your personal information when you participate in our cryptocurrency investment community (the "Community") or interact with our website at 50xclub.com (the "Website").

We reserve the right to modify this Privacy Policy at any time. Changes will be reflected in an updated policy posted on our Website, and we will update the "Last Updated" date accordingly. For material changes that significantly impact your privacy rights, we will provide additional notification. Your continued participation in our Community or use of our Website after changes are made constitutes acceptance of the revised policy.

Scope of This Policy

This Privacy Policy covers information we collect through:

- Our Discord-based cryptocurrency investment community
- Our website at 50xclub.com
- Email communications and other electronic correspondence
- Educational materials and resources hosted on third-party platforms
- Payment processing through our authorized partners

This policy does not apply to:

- Information collected by 50x Club through offline interactions
- Third-party websites, applications, or services that may be linked from our Community or Website
- Independent actions by Discord, payment processors, or other third-party service providers

Age Requirements

Our Community and services are intended for individuals who are at least 18 years of age or the minimum legal age required to engage in cryptocurrency activities in their jurisdiction,

whichever is higher. We do not knowingly collect personal information from individuals under these age requirements.

If you are under the required age, please do not use our services or provide any personal information. If we discover that we have collected information from someone under the required age without proper verification, we will promptly delete such information. Parents and guardians should monitor their children's online activities and ensure they do not access age-restricted content.

Information We Collect

Information You Provide Directly

We collect information that you voluntarily provide when participating in our Community or using our services:

- **Account and Contact Details:** Name, email address, Discord username, and other contact information
- **Payment Information:** Billing details processed through our authorized payment partners (we do not directly store payment card information)
- **Communication Records:** Content from your messages, support requests, and other correspondence with us
- **Community Participation:** Posts, comments, and other content you share in our Discord community
- **Survey and Feedback Data:** Responses to questionnaires, surveys, or feedback requests

Automatically Collected Information

Our systems and third-party partners automatically collect certain technical information:

- **Device and Browser Data:** IP address, browser type, operating system, device identifiers, and language preferences
- **Usage Analytics:** Information about how you interact with our Website and Community, including page views, session duration, and feature usage
- **Location Information:** General geographic location based on IP address
- **Performance Data:** Technical information that helps us maintain and improve our services

Third-Party Data Collection

Our services integrate with several third-party platforms that may collect additional information:

- **Discord:** Collects information according to their privacy policy when you participate in our Community

- **Whop Platform:** Our payment and membership management platform that processes subscription information
- **Stripe:** Payment processing service used by Whop for transaction processing
- **Notion:** Hosts some of our educational content and may collect usage analytics
- **Other Service Providers:** Various tools that help us operate and improve our Community

How We Use Your Information

We use collected information for the following legitimate business purposes:

Community Operations and Improvement

- Facilitate access to our Discord community and educational resources
- Provide customer support and respond to your inquiries
- Monitor and improve the quality of our services and user experience
- Ensure compliance with our community guidelines and terms of service

Analytics and Research

- Analyze usage patterns and trends to enhance our offerings
- Generate statistical insights about our Community (in aggregated, non-identifiable form)
- Conduct research to develop new features and services

Business Operations

- Process membership subscriptions and manage billing
- Send important notifications about your account or our services
- Maintain accurate records for accounting and legal purposes

Marketing and Communications

- Share educational content and market insights that may interest you
- Notify you about new features, services, or community opportunities
- Deliver personalized content based on your interests and participation

Security and Legal Compliance

- Protect against fraud, unauthorized access, and other security threats
- Investigate and respond to violations of our terms and community guidelines
- Comply with applicable laws, regulations, and legal requests
- Protect the rights and safety of our Community members

Information Sharing and Disclosure

We may share your information with third parties in the following circumstances:

Service Providers and Partners

We work with trusted third-party companies that help us operate our business:

- **Payment processors** for handling subscriptions and transactions
- **Technology providers** that host our content and enable our services
- **Analytics services** that help us understand and improve user experience
- **Communication platforms** that facilitate our Community interactions

Legal and Safety Requirements

We may disclose information when required or permitted by law:

- In response to legal process, court orders, or government requests
- To investigate potential violations of our terms or community guidelines
- To protect the safety, rights, or property of 50x Club, our members, or the public
- In connection with the investigation of fraud or other illegal activities

Business Transfers

If 50x Club undergoes a merger, acquisition, or sale of assets, your information may be transferred to the new entity, subject to the same privacy protections outlined in this policy.

Aggregated Information

We may share statistical or aggregated information that does not identify individual users with partners, researchers, or the public.

Cookies and Tracking Technologies

Our Website and services use cookies and similar technologies to enhance functionality and gather usage information:

Types of Cookies We Use

- **Essential Cookies:** Required for basic website functionality and security
- **Analytics Cookies:** Help us understand how visitors use our Website
- **Preference Cookies:** Remember your settings and preferences
- **Marketing Cookies:** Enable personalized content and advertising

Managing Cookie Preferences

Most web browsers allow you to control cookie settings through their preferences. You can typically:

- Block all cookies or only third-party cookies
- Delete existing cookies from your device
- Receive notifications when cookies are being set

Note that disabling certain cookies may limit the functionality of our Website or services.

Data Security Measures

We implement appropriate technical and organizational measures to protect your personal information:

- **Encryption:** Sensitive data is encrypted in transit and at rest
- **Access Controls:** Limited access to personal information on a need-to-know basis
- **Regular Security Reviews:** Ongoing assessment and improvement of our security practices
- **Third-Party Security:** We work only with service providers that maintain appropriate security standards

However, no internet transmission or electronic storage system is completely secure. While we strive to protect your information, we cannot guarantee absolute security.

Your Privacy Rights

Depending on your location, you may have certain rights regarding your personal information:

Access and Portability

- Request access to the personal information we hold about you
- Receive a copy of your data in a portable format

Correction and Update

- Request correction of inaccurate or incomplete information
- Update your account information and preferences

Deletion

- Request deletion of your personal information, subject to legal and operational requirements
- Close your account and remove associated data

Opt-Out Rights

- Unsubscribe from marketing communications
- Opt out of certain data processing activities where legally required

International Data Transfers

50x Club operates from the United Arab Emirates and serves a global community. Your information may be transferred to and processed in countries other than your own, including countries that may have different data protection laws.

When we transfer information internationally, we implement appropriate safeguards to protect your data in accordance with applicable privacy laws.

Data Retention

We retain your personal information only as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law.

Factors that influence our retention periods include:

- The nature and duration of our relationship with you
- Legal and regulatory requirements
- The need to resolve disputes or enforce our agreements
- Legitimate business interests in maintaining accurate records

We may update this Privacy Policy periodically to reflect changes in our practices, services, or applicable laws. When we make material changes, we will notify you through our Website, Community announcements, or email.
