Welcome to chasechappell.com and adsmastery.com (collectively, the "Websites"), owned and operated by Chappell Training Technologies LLC ("Company," "we," "us," or "our"). This Privacy Policy describes how we collect, use, disclose, and protect your personal information when you visit our Websites, use our services, or interact with us.

This Privacy Policy applies to all information collected through our Websites, email communications, social media interactions, and any related services, sales, marketing, or events (collectively, the "Services").

By using our websites or services, you agree to the terms of this Privacy Policy and consent to our collection, use, and disclosure of your information as described herein.

1. Information We Collect

We collect the following types of information in several ways:

A. Information You Provide Directly

B. Information Collected Automatically

When you use our Services, we automatically collect:

- Time spent on pages
- Click patterns and navigation paths
- Search terms and referral sources
- Date and time of access
- Mobile device information (if applicable)

C. Information from Third Parties

We may receive information about you from:

- Social media platforms (when you connect or engage with us)
- Payment processors and financial institutions
- Marketing partners and affiliates
- Public databases and data aggregators
- Other users who refer you to our Services

2. How We Use Your Information

We use your information to:

- Provide, operate, and maintain our Services
- Process transactions and send confirmations
- Create and manage your account
- Provide customer support
- Communicate with you about your account, our services, offers, and updates
- Send marketing communications (with your consent where required you can opt out at any time)
- Conduct analytics to improve our Services and user experience
- Personalize your experience and content
- Detect, prevent, and address fraud and security issues
- Comply with legal obligations
- Protect our rights and interests
- Facilitate business transfers or transactions

Marketing Communications

We may send you marketing emails, newsletters, and promotional materials. You can opt out at any time by:

3. Legal Bases for Processing (International Users)

For users outside the United States, we process your personal information based on the following legal grounds:

- Consent: When you have given clear consent for specific processing activities

- Legal Obligation: To comply with applicable laws and regulations
- Legitimate Interest: For our business operations, fraud prevention, and service improvement

4. How We Share Your Information

We do not sell, rent, or trade your personal information. We may share your information in the following circumstances:

- Trusted third-party vendors who assist in operating our website, processing payments, managing emails, analytics, and customer service including:
 - Payment processors (Stripe, PayPal, etc.)
 - Email service providers (Mailchimp, ConvertKit, etc.)
 - Analytics providers (Google Analytics, Facebook Analytics)
 - Customer support platforms
 - Cloud storage and hosting providers
 - Marketing automation tools
- Legal authorities when required by law or to protect our rights including:
 - Responding to legal requests and court orders
 - Protecting against fraud and abuse
 - Enforcing our Terms of Service
 - Defending legal claims
- Business transfers, in the event of a merger, acquisition, or asset sale where your information may be transferred to the acquiring entity

All third parties are contractually required to maintain the confidentiality and security of your data and may only use it for the purposes we specify.

No Sale of Personal Information

We do not and will not sell your personal information to third parties for monetary consideration. However, we may share information for advertising purposes, which some privacy laws consider a "sale." You can opt out of this sharing using the methods described in Section 9.

5. Cookies and Tracking Technologies

We use cookies and similar technologies to:

7. Data Retention

We retain your personal information for as long as necessary to:

- Resolve disputes and enforce agreements

Specific retention periods:

- Account information: Until account deletion plus 7 years
- Transaction records: 7 years from transaction date
- Marketing data: Until you opt out plus 3 years
- Support communications: 3 years from last contact
- Analytics data: 26 months (Google Analytics default)

However, no method of transmission or storage is 100% secure. While we strive to protect your information, we cannot guarantee absolute security.

If we experience a data breach that affects your personal information, we will notify you and relevant authorities as required by law.

8. Your Privacy Rights and Choices

You have the following rights regarding your personal information:

- Access: Request access, to your personal information
- Correction: Request correction of inaccurate information
- Deletion: Request deletion of your personal information subject to legal retention requirements
- Portability: Request a copy of your data in a portable format
- Restriction: Reguest limitation of processing in certain circumstances
- Objection: Object to processing based on legitimate interests
- Opt-out: Withdraw consent for marketing emails and data sharing for advertising
