# REFUND POLICY & MASTER SERVICE AGREEMENT (MSA)

Effective Date: August 26, 2025

**Parties:** This Master Service Agreement ("Agreement") is entered into by and between:

#### 2. Service Completion

- **2.1** The Service is considered fully delivered and complete upon purchase.
- **2.2** Any further use or setup within WHOP or TradingView is the responsibility of the Customer and does not extend or alter the completion of the Service.

#### 3. Fees & Refunds

- **3.1** Fees are due at the time of purchase.
- **3.2** Because Services are delivered instantly upon purchase, refunds are not required under any circumstances.
- **3.3** Refunds may be granted solely at our discretion, but we are under no obligation to approve them.

## 4. Customer Obligations

  - Providing accurate account details to connect your TradingView and WHOP accounts;
  - Maintaining valid TradingView and WHOP accounts in good standing.
