

# Copy Academy Terms of Service

Thank you for purchasing Copy Academy (the "Course"), created and taught by Tom Stoic (referred to as "we," "us," or "our"). This Agreement outlines the terms and conditions for your participation in the Course. By purchasing this Course, you (the "Customer") are agreeing to these Terms of Service (the "Agreement"). ## 1. Acceptance of Terms

By purchasing Copy Academy, you are required to agree to these Terms of Service. You will be prompted to tick a box to indicate that you accept these terms before completing the purchase.
