

LeadsAutopilot Terms of Service

Last updated: 17 November 2025

These Terms of Service ("Terms") govern your access to and use of the LeadsAutopilot service ("LeadsAutopilot", "we", "our" or "us"), including the website, software, tools, APIs, and related services. By creating an account, purchasing a membership, or using any part of the service, you agree to these Terms.

1. Overview of Service

LeadsAutopilot is a subscription-based platform that provides access to LinkedIn automation tools and related features. Upon account creation and successful payment, you receive immediate access to the platform. A valid, active membership is required to use any tools.

Your membership continues and recurring charges will apply regardless of which specific tools you choose to enable or disable. Disabling one or more tools does not pause, cancel, or reduce your membership fees.

2. Payments and Billing

All payments are processed by our merchant of record, **Whop**, with its principal office at: 300 Kent Avenue, Brooklyn, NY, United States, 11249.

By subscribing you authorize Whop to charge the payment method you provide at checkout on a recurring basis until you cancel in accordance with these Terms. You are responsible for maintaining accurate and up-to-date payment information. Failed or disputed payments may result in suspension or termination of service.

3. Refund Policy

We offer a **7-day full refund** for new purchases, measured from the date of the original purchase.

To request a refund you must contact support@leadsautopilot.com from the same email address used to make the purchase. We will not process refund requests sent from an email address that does not match the purchase email, except where required by law.

Refunds will be denied if:

- The request is made after the 7-day refund window;
- The request is submitted from an email address different from the purchase email (unless we can verify identity by other means);

- You have violated these Terms or applicable law;
- We reasonably determine that the refund request is fraudulent.

4. Use of the Platform

You agree to use LeadsAutopilot in compliance with all applicable laws, regulations, and third-party terms, including LinkedIn's terms of service and any other platform terms that apply to your activity. You are solely responsible for how you use the service and for ensuring that your use does not violate the rights of third parties.

We reserve the right to monitor, limit, restrict, suspend or terminate access to any account that (in our sole discretion) abuses the service, attempts to circumvent limitations, or otherwise violates these Terms. You are responsible for maintaining the confidentiality and security of your account credentials; any activity originating from your account is your responsibility.

5. Memberships, Cancellations and Renewals

Memberships renew automatically at the end of each billing period unless canceled. You may cancel your subscription via your Whop account. Cancellation stops future recurring charges but does not entitle you to refunds except as stated in the Refund Policy above.

We may, at our discretion, suspend or terminate access for non-payment, suspected fraud, or other breaches of these Terms. Termination by us does not relieve you of outstanding payment obligations incurred prior to termination.

6. No Warranty; Limitation of Liability

LeadsAutopilot is provided "**as-is**" and "**as-available**", without warranties of any kind, express or implied. We expressly disclaim all warranties, including implied warranties of merchantability, fitness for a particular purpose, accuracy, reliability, and non-infringement.

We do not guarantee any particular results, outcomes, income, business metrics, or a specific number of actions, interactions, followers, or engagements. While we attempt to provide reliable service and reasonable uptime, we make no promises regarding availability, performance, or response times.

To the fullest extent permitted by law, in no event will LeadsAutopilot, its officers, directors, employees, agents, or affiliates be liable for any indirect, incidental, special, consequential, exemplary or punitive damages, or for any loss of profits, revenue, data or business opportunity arising out of or in connection with these Terms or your use of the service, even if we were advised of the possibility of such damages.

To the extent that any claim is not subject to arbitration under applicable law, you agree to submit to the exclusive jurisdiction of the state and federal courts located in Delaware.

12. Miscellaneous

If any provision of these Terms is found to be invalid or unenforceable, that provision will be enforced to the maximum extent permitted and the remaining provisions will remain in full

force and effect. These Terms constitute the entire agreement between you and LeadsAutopilot regarding the service and supersede any prior agreements.
