These Terms of Service (“Terms,” or “Agreement”) constitute a legally binding agreement between you (“you,” “user,” “member”) and Astra Trading LLC (“Astra,” “Company,” “we,” “us,” “our”), regarding your access to and use of:

- Any Astra-affiliated social media communications
- Any membership access or billing managed through Whop

By accessing Astra, you agree to these Terms.

1. Changes to These Terms

Astra may modify these Terms, pricing, membership features, or website information at any time, for any reason.

Changes take effect immediately when updated.

Continued use of Astra Services constitutes acceptance of the changes.

2. Eligibility

4. Nature of Real-Time Setups

"Real-time setups" shown inside Astra are:

- Personal trades executed by the Astra founders
- Shared for educational and informational purposes only
- Demonstrations of our own processes, decision-making, and risk-management approaches

Real-time setups:

- Are NOT signals
- Are NOT trade alerts
- Are NOT recommendations
- Do NOT guarantee outcomes

- Do NOT create any advisor-client relationship

You acknowledge that all trade decisions you make are your own.

5. Role of Expert Traders & Mentorship

Astra's "expert traders":

- Provide educational commentary only
- Help users understand technical analysis, risk management, and general trading concepts
- Offer opinions and general feedback in response to questions
- Do NOT provide individualized advice
- Do NOT assess your financial situation
- Do NOT tell you what to buy or sell
