

End User License Agreement (EULA)

For MT4 OneClick

Last updated: January 2025

This End User License Agreement ("Agreement") is a legal agreement between you ("User") and MT4 OneClick ("Licensor"), governing the installation and use of the MT4 OneClick software ("Software"). By downloading, installing, activating, or using the Software, you confirm that you have read, understood, and agree to be bound by this Agreement.

If you do not agree with any part of this Agreement, do not install or use the Software.

1. Grant of License

The Licensor grants the User a non-exclusive, non-transferable, revocable license to install and use one (1) licensed copy of MT4 OneClick on one (1) computer, strictly bound to a unique CID (Computer ID).

This license does not constitute a transfer of ownership. All rights not expressly granted in this Agreement remain the exclusive property of the Licensor.

2. License Types

The Software may be provided under the following license models:

2.1 Monthly Subscription License

A subscription-based license valid as long as recurring payments remain active. Expiration occurs immediately upon non-payment or cancellation.

2.2 Lifetime License

A one-time purchase granting long-term access under conditions defined in the **Refund & License Policy**.

Activation is permanently bound to the User's CID and cannot be moved, transferred, or shared.

2.3 Free Learning Trial / Starter Package

If applicable, the User may receive limited-time access for evaluation and learning purposes. Trial licenses cannot be transferred and may include restricted functionality.

3. Installation & Activation

- Each license is tied to a single CID, representing one hardware device.
- Installing or activating the Software on additional systems requires purchasing additional licenses.
- The User is responsible for ensuring that the CID provided during activation belongs to the intended device.
- Any attempt to manipulate, spoof, or alter the CID or licensing mechanism is strictly prohibited.

4. Prohibited Uses

The User shall not, under any circumstances:

- Copy, share, resell, rent, lease, sublicense, or distribute the Software to any third party.
- Publish or make the Software or license key publicly available.
- Reverse engineer, decompile, modify, translate, or attempt to derive the source code.
- Bypass, modify, or disable license verification or activation mechanisms.
- Use the Software for illegal, malicious, or unauthorized activities.
- Use the Software on more than one device per license.

Any violation of these terms will result in immediate license termination without refund.

5. Ownership and Intellectual Property

All copyrights, trademarks, proprietary technology, and intellectual property associated with MT4 OneClick remain the exclusive property of the Licensor.

The Software is licensed, not sold.

6. Software Updates

The Licensor may provide updates, improvements, patches, or new versions of the Software. Updates may include bug fixes, optimizations, or feature enhancements.

The Licensor reserves the right to:

- Modify access or functionality
- Discontinue features
- Retire outdated versions
- Require updates for continued use

Use of updated versions remains subject to this Agreement.

7. Financial Disclaimer

MT4 OneClick is an automation and workflow tool designed to enhance efficiency within the MetaTrader platform. It does not provide financial advice, investment guidance, or guarantees of profit.

All trading decisions are made solely by the User. The Licensor shall not be liable for losses, damages, or financial harm resulting from trading activity.

This clause aligns with the limitations in the existing **Terms of Service**.

8. Limitation of Liability

To the maximum extent permitted by law:

The Licensor is not liable for indirect, incidental, consequential, or punitive damages, including loss of capital, profits, or data.

The User assumes full responsibility for any risks associated with the use of automated trading tools.

This aligns with the liability limitations described in the **Terms of Service**.

9. License Revocation

The Licensor may revoke the license immediately if:

- A refund or chargeback occurs
- Unauthorized distribution or sharing is detected
- Abuse, fraud, or violation of this EULA is identified
- The User manipulates the licensing system

Revocation disables activation, updates, and any future access to the Software.

(Aligned with **Refund & License Policy**, Section 4.)

10. Refunds

Refunds are governed strictly by the existing **Refund & License Policy**, which forms part of the

licensing framework.

Key rules (short summary):

- Refunds are not available once a license has been activated.
- Refunds may be considered only if the Software has not been activated and within 30 days of purchase.
- Lifetime licenses are non-refundable once activated.

For complete conditions, see the **Refund & License Policy**.

11. Privacy and Data Usage

Use of the Software and website is also governed by:

- Privacy Policy
- Terms of Service

These documents outline how personal data is processed, stored, and protected.

The Software does not collect or transmit personal trading data except where required for licensing or fraud detection.

12. Governing Law

This Agreement is governed by the laws of:

- The Republic of Slovenia, until corporate registration transitions to
- The Republic of Estonia, after which all legal matters fall under Estonian jurisdiction.

13. Termination

This Agreement remains in effect until:

- Terminated by the User (by discontinuing use), or
- Terminated by the Licensor for breach of this Agreement.

Upon termination:

- The User must cease all use of the Software
- All components must be removed from the device
- Access to updates or activation is revoked

- No refunds are issued upon termination due to breach.

14. Entire Agreement

This Agreement represents the complete understanding between the User and the Licensor regarding the Software. It supersedes all prior oral or written agreements related to licensing.
