By installing and using the OneStopSocial Chrome Extension or visiting our website, you agree to the practices outlined in this Privacy Policy and our Terms of Use. If you disagree with any part of these policies, please discontinue use of our services immediately.

Information We Collect

- Name
- Email address
- Phone number (optional)
- IP address and session/browser metadata
- Keywords you input into our extension
- Analytics data on website and extension usage
- Billing information (processed by Stripe)

Note: We do not collect or store any private messages, personal content, or sensitive information from your social media accounts.

Use of Data

- Your keywords are used exclusively to filter and surface relevant posts from Facebook Groups.
- Website and extension analytics help us improve functionality and user experience.
- We may use aggregated usage patterns to understand engagement or improve features.
- We do not store or process the content of posts beyond temporary caching to provide keyword-matching features.

Facebook Data Handling

We do not permanently store, access, or share any personal data from Facebook or any other social media platforms.

- The only data temporarily cached is publicly visible Facebook Group post content that your browser has access to, for the sole purpose of keyword matching.
- This cached data is stored locally in your browser and auto-deletes within 30 days.

Payment Security

All payment transactions are securely processed by **Stripe**. OneStopSocial does not store any of your credit card information.
