## - END USER LICENCE AGREEMENT (EULA)

This End User Licence Agreement (“Agreement”) governs your use of Dynamic Traders Club (“DTC”) educational materials, community access, tools, indicators, and related digital content provided by Ziba Online Limited (“ZOL”, “we”, “our”).

By joining DTC or accessing any associated content, you agree to this Agreement, our Terms of Service “TERMS OF SERVICE”, and our Privacy Policy.

### 1. Purpose & Scope

DTC provides educational and informational content only, including courses, market discussions, tools, indicators, and community resources.

Nothing provided constitutes financial advice, portfolio management, signals, or investment services.

### 2. Licence Grant

We grant you a personal, limited, non-exclusive, non-transferable, revocable licence to access and use DTC materials for your own educational use only, including:

- Backtesting walkthroughs
- Educational discussions
- Trading concepts and demonstrations
- DTC alerts and trading opportunity notifications via TradingView indicators
- Discord community access
- Proprietary indicators and chart tools

You receive access, not ownership.

### 3. Licence Restrictions

Your licence does not permit copying, sharing, redistributing, or reselling any DTC content or tools.

You agree NOT to:

3.1 Share any proprietary content

Including:

- course videos
- PDFs or written materials

- alerts, levels, or analyses
- screenshots of tools or indicators
- Discord discussions or private chats
- backtesting walk-throughs
- session recordings

### 3.2 Share your access credentials

You may not:

- share Whop logins
- share Discord access
- provide your TradingView username login to others

### 3.3 Record or rebroadcast internal content

You may not:

- screen-record lessons
- livestream or publish indicator output
- display DTC tools in other communities
- reshare trades or analysis as your own

### 3.4 Reverse-engineer or replicate tools

You may not inspect, copy, replicate, adapt, or extract underlying code or logic from DTC TradingView indicators or tools.

### 3.5 Engage in misconduct

We may revoke access for:

- abusive behaviour
- defamation
- illegal activity
- sharing protected materials
- breaching confidentiality

(Aligned with ToS Section 6 TERMS OF SERVICE)

## 4. Access Requirements

Your licence is linked to an active Whop subscription.

If your subscription ends, lapses, or is cancelled:

- course access ends
- indicator access is revoked
- alerts stop

- Discord access ends
- tools and bonus features stop

DTC may also modify, pause, or retire features that become under-utilized or impractical to maintain, as allowed under the Terms of Service.

## **5. Confidentiality**

All non-public materials are confidential and exclusively for DTC members.

You agree not to share:

- conversations
- screenshots
- session notes
- staff responses
- private strategies or workflows

(Aligned with ToS Section 16TERMS OF SERVICE)

This protects the experience and integrity of the program.

## **6. Educational Use Only**

All DTC content is for educational purposes only. We do not:

- guarantee financial results
- provide signals
- tell you where or when to trade
- provide investment advice
- ensure funding outcomes

Trading involves risk, including total loss.

## **7. Refunds**

DTC subscriptions, courses, and digital products are non-refundable once access is granted, except in cases of:

- duplicate billing
- technical delivery failure
- inability to access the purchased content

Refunds are not provided for:

- trading performance
- subjective satisfaction

- lack of results

We may suspend or revoke access without refund if you:

- violate this EULA
