

Privacy Policy

1. Introduction

WagerFunding (“WagerFunding,” “we,” “our,” or “us”) respects your privacy and is committed to protecting your personal information. This Privacy Policy explains what data we collect, how we use it, why we collect it, and what choices you have. By accessing or using wagerfunding.com (the “Site”), you agree to the practices described in this policy.

2. Information We Collect

- Identifying and Contact Information – When you create an account, make a purchase, join a challenge, or contact us, we may collect your name, mailing address, email address, and phone number.
- Financial Information – If you buy products or receive payouts, we collect payment details such as credit card or other transaction data to process payments securely.
- Technical and Usage Data – When you visit our Site, we automatically collect IP address, browser type, referring pages, time spent, and actions taken. Cookies may be used to improve your experience (see Section 5).

We collect only information you voluntarily provide, except for standard technical data gathered automatically through web technologies.

- Service Providers & Partners – Payment processors, hosting providers, analytics services, etc.
- Affiliates & Marketing Partners – Limited shared info for relevant offers (opt-out available).

- Sale or Lease of Data – Personal information may be sold or leased when necessary for account creation or functionality (opt-out available).
- Legal Requirements – Disclosure as required by laws, orders, or to protect safety.

5. Cookies and Tracking Technologies

Cookies store preferences, enhance navigation, and personalize your experience. Disabling cookies may limit functionality.

6. Security

We use SSL encryption and industry-standard protections. No system is fully secure, and you accept this inherent risk.

7. Your Privacy Choices and Rights

- Right to Know – Request details on stored personal data.
- Right to Opt-Out – Stop sale or sharing of your data.
- Right to Deletion – Request deletion unless legally restricted.
- Marketing Opt-Out – Unsubscribe via links or by contacting support.
