

Terms of Service

1. Overview and Acceptance

By creating an account, making a purchase, or using the Platform, you agree to these Terms, Contest Rules, and Privacy Policy. Do not use the Platform if you disagree.

2. Eligibility and Allowed Regions

You must be 18+ or the local age of majority. Users in Idaho, Iowa, Louisiana, Mississippi, Montana, Nevada, and Washington are prohibited. VPNs or location masking tools are not allowed.

3. Nature of the Services

WagerFunding provides skill-based challenges using virtual points. It is not a casino, sportsbook, or gambling operator.

4. Accounts and Security

One account per person. You are responsible for all activity and must report unauthorized access immediately.

5. Purchases, Billing, and Refunds

All purchases are final. Valid payment methods are required. Chargebacks may result in account closure.

6. Rewards and Redemptions

Rewards are redeemable according to Contest Rules. Incorrect payout details are the user's responsibility.

7. Skill Scoring and Results

Official statistics control final results. Server data prevails over device display.

8. Promotions and Special Offers

Promotions may have separate terms. Abuse may result in removal of benefits.

9. Fair Play and Prohibited Conduct

No cheating, collusion, bots, malware, money laundering, or exploitation of bugs. Investigations may delay redemptions.

10. Verification and Compliance

Identity, age, and geolocation checks may be required. Delays may occur until verification is complete.

11. Service Availability and Changes

The Platform is provided “as is.” We may modify or discontinue features at any time.

12. Intellectual Property and User Content

All Platform content is owned or licensed by WagerFunding. Submitted content grants us a perpetual license.

13. Third Party Links and Tools

External sites are used at your own risk.

14. Privacy

Use of the Platform is subject to the Privacy Policy.

15. Communications

We may send transactional and marketing communications. You may opt out of marketing messages.

16. Complaints and Support

Use your account email and include all relevant details to speed resolution.

17. Account Closure

You may request closure anytime. We may close accounts for violations.

18. Indemnification

You agree to indemnify WagerFunding and affiliates for losses resulting from your actions.

19. Limitation of Liability

WagerFunding is not liable for indirect or consequential damages. Total liability is limited to amounts paid in the last 30 days.

20. Dispute Resolution and Arbitration

Disputes will be resolved via binding arbitration administered by JAMS. You may opt out within 30 days.

21. Taxes

Users are responsible for all applicable taxes.

22. Geolocation

We use third-party tools to verify location. Bypassing controls is prohibited.

23. Updates to These Terms

Terms may be updated. Continued use means acceptance.

These Terms constitute the entire agreement. Invalid provisions will be interpreted to reflect original intent.
